PART I - DEFINITION OF THE COMPETITION

1. SUBJECT OF THE COMPETITION

The Municipality of Milan and M4 SpA (hereinafter referred to as "Competition Authority") promotes an international design competition through "San Cristoforo". The competition is open for the design of the intermodal Hub and the cycle-pedestrian connection between the Lorenteggio and Ronchetto sul Naviglio districts whose purpose is the acquisition of a project with an in-depth level equal to that of a technical and economic feasibility project.

In particular, the competition has as purpose:

SCOPE 1 - technical economic feasibility project

- Scope 1A: the design of the connecting bike and walk path between the Lorenteggio and Ronchetto sul Naviglio districts, which will extend from the northern boundary of the Piazza Tirana green area to the "Ronchetto" intermodal hub, including all the ramps and vertical links, the lighting system and parapets; the entrance to the subway of the M4 station and the pedestrian connection between this and the future linear park. The design development of the subsequent levels will be entrusted by CMM4/Metroblu to the winner of the competition, as described in art. 21 of this announcement.
- **Scope 1B:** the design of the intermodal hub in the area between via Lodovico il Moro and via Guido Martinelli. The planning development of the subsequent aspects will be entrusted by the Municipality of Milan, as described in art. 21 of this announcement.
- Scope 1C: the design of the bike and walk path link between via Martinelli and the southern border of the future interchange area, close to the Enna-Chiodi road network. The planning development of the subsequent levels will be entrusted by the Municipality of Milan, as described in art. 21 of this announcement.

The technical-economic feasibility project will have to demonstrate the compatibility of the construction time of the path (Scope 1A) with the M4 times, so the construction of this work will not last more than **18 months** taking into account the constructional complexities due to the rail crossing (with possible subjection to use) and to the presence of the Naviglio.

SCOPE 2 - drafting guidelines

- **Scope 2A:** Guidelines, for the reconfiguration of the Piazza Tirana area in the area that extends from the San Cristoforo railway station to the northern boundary of the green area.
- Scope 2B: Guidelines for the interchange area that will develop south of via Martinelli

SCOPES 1 and 2 are represented on Table 3.2 "Table with perimeter area of competition".

The objectives and the guidelines for the design, with a detailed description of the contents and the objectives to be pursued, can be found in the Preliminary Design Document (Documento Preliminare alla Progettazione, hereinafter, for the sake of brevity, DPP), attached as an integral part of this competition.

The maximum total cost of the works relating to the **Areas 1A, 1B and 1C** is set at € **13,947,000.00** divided into the following amounts:

- Scope 1A: the cost of the works must be a maximum of € 12,000,000.00 excluding VAT. This amount includes, in addition to the costs of the works for the construction of the work, all the costs of construction, preparation, eventual subjection to traffic (rail and road). It is also considered a design constraint and is covered in the economic analysis of the M4 work. The external safety burdens and other necessary burdens will be charged separately and will also be covered by the M4 economic analysis.
- Scope 1B and 1C: the cost of realization of the works must be a maximum of € 1,947,000.00 (VAT excluded); external security charges and other necessary charges will be assessed separately. These amounts will be covered by loans to be borne by the Municipality of Milan.

2. PROCEDURE TYPE

The competition, with an open procedure, is articulated in a sole instance aimed at identifying the best design proposal among those presented within the deadline.

To guarantee anonymity and uniform conditions of participation, the procedures of the competition and the relationship between the Competition

Authority and candidate will take place exclusively via the website

www.sancristoforo.concorrimi.it.

The candidate can register and log into the site mentioned above to download the material necessary for participation, formulate questions, consult the page "news" and deliver the design proposals by uploading them onto the site.

The system shall assign an alpha-numeric code (registration number) to each participant, and ensure anonymity for the entire procedure¹.

PART II - PARTICIPATION TO THE COMPETITION

3. SUBJECTS ALLOWED TO THE COMPETITION: APPLICATION REQUIREMENTS

The competition is open to Architects and Engineers registered in the respective Professional Associations or professional registers of the countries to which they belong, qualified to exercise the profession on the date of publication of the present Competition Notice which do not incur in the grounds for exclusion pursuant to art. 80 of Legislative Decree 50/2016 and following amendments and integrations

Specifically, all the parties referred to in art. 46 paragraph 1 of the Leg. Decree 50/2016 and following amendments and integrations in possession of the requirements of the Ministerial Decree 263/2016 and following amendments and integrations

The participation of junior architects and junior engineers is allowed within the limits of the provisions of art. 15 and following (for the profession of architect) as well as art. 45 and following (for the engineering profession) of the d.P.R. 328/2001 and following amendments and integrations

The competitors can participate individually or jointly through groupings. In the case of grouping, a group leader must be appointed as the sole responsible and referent towards the Competition Body.

The group represents one single entity for the competition and the authorship of the project is recognised, with equal rights, for all members of the group².

Groups, even if not yet formally recognised, shall foresee the presence of at least one project designer holding a degree and authorised to the profession since at least 5 (five) years prior to the date of the Competition Notice, according to the Ministerial Decree 263/2016 and following amendments and integrations Competitors, both individuals and groups, may avail themselves of consultants and collaborators, even if these are not registered in professional associations.

For each consultant and collaborator, a declaration on his/her certification and the nature of his/her consultancy and collaboration shall be provided. Tasks and assignments of consultants/collaborators are defined within the group, with no relevance for the relationship between the competitor and the Competition Authority.

In order to be admitted into the competition, competitors are not subject to the requirements of Article 83 of the code, as required by the following article 21 of this document, which must be demonstrated exclusively by the winner after the conclusion of the competition procedure and before of the negotiation procedure aimed at the tender of the following design aspects and other services related to architecture and engineering, including also through a pooling contract or the constitution of a temporary group.

4. REASONS OF INCOMPATIBILITY AND EXCLUSION

Following situations represent grounds of exclusion according to art. 80 of Legislative Decree 50/2016 and following amendments and integrations Following potential participants are not allowed to take part into the Competition:

- subjects who contributed to the drafting of the present Notice of Competition and attached documents, their spouses and relatives up to the fourth degree (included) and people with a current work relationship or other linkage with the former persons. By linkage we imply work relationships, even in the same work environment, which has given rise to a reciprocal interpenetration of the respective professional activities from a technicalorganisational point of view;
- 2. those subjects who may be favored due to the execution of relevant preliminary performance of the

- Competition and/or their involvement in the drafting of the Notice and its attachments or in the implementation of the Competition;
- 3. employees of the Competition Authority or any subject, detaining at the date of the publication of the present Notice of Competition any type of collaboration with the Competition Authority having as scope the subject of the competition. The incompatibility includes also spouses and relatives up to the fourth degree (included);

The participation of any type (group leader, member of the group, consultant, collaborator) of any competitor in more than one group results in the exclusion of both the individual competitor and of the group/s the beforementioned competitor is part of.

Participants and members of the Jury are not allowed to get in contact about the competition for the entire duration of the Competition, under penalty of exclusion

5. ACCEPTANCE OF THE TERMS OF NOTICE

The participation into the Competition implies the participant's full acceptance of all terms and regulations of the present Competition Notice and its attachments.

Participants exempt the Competition Authority from the responsibility related to any malfunctioning and fault related to the connection services required to reach the telematic system to receive design proposals and related documents.

6. INVESTIGATION PROCEDURE

The deficiencies of any formal element of the application, with the exclusion of those relating to the project proposal, can be remedied through the procedure of preliminary investigation referred to in paragraph 9, article 83 of Legislative Decree no. 50/2016 and following amendments and integrations The Competition Authority entitles the competitor (maximum ten days) to file, integrate or settle the required documents and certifications, within a specific deadline, thus indicating the content and subjects that shall provide them. After the above-mentioned deadline or in case of inadequacy of the integrations, the competitor is excluded from the Competition.

7. PAYMENT OF THE ANAC (National Anti-Corruption Authority)

Within the deadline for the delivery of the works, under penalty of exclusion from the competition, pursuant to Resolution No. 1300 of 20 December 2017 and subsequent amendments, the competitor shall make payment to the National Anti-Corruption Authority - ANAC³, amounting to €35.00 as contribution for participation in the present competition, following the operating instructions provided by the Authority on the website: www.anticorruzione.it (online services - collection of contributions).

Payment can be made starting from 24 hours after the completion, by the organizer, of the procedure for transmitting the information required by the Competition Monitoring Information System (SIMOG).

No guided visits are planned, as most of the area is freely accessible. It should be noted that the areas inside the M4 sites are not accessible for security reasons. Any requests to visit the construction sites will be assessed compatibly with the work in progress.

10. TECHNICAL DOCUMENTS REQUIRED

The technical and economic feasibility project, which the competitors must present, consists of the following documents:

1. Project explanatory technical report

The report shall explain the project and provide the required indications for the continuation of the project development.

In detail, the report must address the following topics in relation to the required design areas and sub-projects:

- explanation of the reasons for the proposed solution and motivation of the architectural and technical choices of the project, a general description of the design solution from the functional point of view;
- description of the characterization of the project from the point of view of the insertion in the reference context and the relationships with the surrounding tissue;
- description of the project criteria aimed at environmental, energy and economic sustainability; evaluations
- of the landscaping insertion of the work, considering that after the competition the project must be submitted to the landscaping authorization procedure, in accordance with article 146 of Legislative Decree 22 January 2004, n. 42 and subsequent amendments and additions, as it falls within the ambit of landscape protection;
- accessibility, use, ease and economy of maintenance and management of project solutions;
- aspects of the project that are not evident in the graph documents to be highlighted;
- construction methods and possible bike walk path phases, in consideration of the need to flyover 4 railway tracks and the Naviglio Grande, detailing any subjection to railway activities; addresses for the drafting of
- the final project;
- first indications and measures aimed at the protection of health and safety during construction phase for the drawing up of safety plans and relative economic estimate;
- report on financial and economic aspects of the project;
- design guidelines for the reconfiguration of the areas of Piazza Tirana and of the area between Via Martinelli and the new Enna-Chiodi roadway "Scope 2", with possible graphic elaboration of a suitable scale and free technique:
- explanatory abstract of the project, with a maximum of 3,000 characters, that the Competition Authority can
 use during the exhibitions, exhibitions and publications referred to in Article 20 "Exhibition and publication of
 the project proposals" of the present Notice.

The report may contain images and graphs and shall be included in a file of maximum 19 pages UNI A3 format plus cover page, horizontal layout (maximum 3,500 characters spaces included for each page), with reduction of 6 tables (PDF format).

- project; structure construction modes;
- type of proposed decks and materials used;
- architectural profiles of the dimensions of the works in relation to the other infrastructures present (railway
- line and Naviglio) overall render inserted in the reference context.

Technical and graph documents shall be included in 6 (six) tables — UNI Al format, vertical layout (PDF format).

3. General cost estimate

The general calculation of the expenditure must be provided, separate for **the 1A, 1B, 1C aspects**, which must be contained in a maximum of 8 pages UNI A4 plus the cover on a PDF file. It must be calculated according to the price lists that can be downloaded from the contest website. If an item that is to be used is not included in the aforementioned price lists, it will be up to the competitor to conduct a market survey and to communicate, in the project documentation sent, the methods used to define the new price used for the calculation of the expenditure.

Solutions which are expected to exceed the maximum foretasted costs equal to

- € 12,000,000.00 for Scope 1A
- and 1,947,000.00 € for the Scopes 1B and 1C are not admitted.

The costs must be inclusive of the preparations for the execution of the works and any provisional works envisaged in the project and anything else necessary for the realization of the works. External safety charges are excluded.

The number and the indications at points 1, 2 and 3 of the present paragraph shall coincide with the aim of the Competition Authority to obtain a technical and economic feasibility project.

Competitors shall provide a specific methodological approach in the use of the BIM technology (Building Information Modeling).

PART III - WORKS OF THE JURY - COMPETITION RESULTS

13. JURY — PRELIMINARY EXAM

The Commission of selection will be constituted according to the Guidelines No. 5 of the National Anti-corruption Authority - ANAC - and will be composed of expert members, external to the Competition Body, identified through drawing⁶ within the list provided by the ANAC and subsequently at the end of the delivery of the project proposals⁷.

Drawing by the experts who will be appointed to form the jury will take place via public

hearing of a special drawing commission made up of internal members of the Competitor Body, whose minutes will be drawn up, which will take place after the deadline for the submission of project proposals. The date and time of the public hearing will be published on the website **www.sancristoforo.concorrimi.it**

The particular complexity of the tender, due to the characteristics that the selected project must possess to meet the required objectives, means that:

- the number of members of the jury is equal to 5 (five);
- the jury is composed of experts from different areas and specializations: Architect / Landscape Designer / Territorial Planner / Civil and Environmental Engineer;
- the number of experts among which to draw the members of the jury is equal to three times the number of members to be appointed, also to ensure the possibility of finding highly experienced professionals, and therefore equal to 15 (fifteen).

Until the adoption of the regulations concerning the registration in the Register referred to in Article 78 of Legislative Decree no. 50/2016, the jury continues to be appointed by the body of the contracting authority responsible for making the choice of the subject awarded the contract, according to rules of competence and transparency previously identified by each contracting authority.

The Jury shall avail itself of a Secretary, with no right to vote; this person shall be chosen by the Competition Authority. The sessions of the Jury are valid upon presence of all members. Decisions of the Jury are taken by majority and are binding for the Competition Authority.

Candidates who fall into one or more of the causes of incompatibility, abstention or exclusion pursuant to art. 77 of Legislative Decree no. 50/2016 and paragraphs 3.6 and 3.7 of the Guidelines no. 5 are not admitted into the jury. The selection of the President of the Jury will be performed by the members, before the evaluation of the project proposals⁸.

The evaluation of the projects by the Jury is preceded by a preliminary examination of the projects

produced by competitors without any substantive assessment by the Competition Coordinator and the Secretariat. This examination aims at verifying the number and format of documents required by the Competition Notice. On the result of the preliminary examination, a Report is drawn up, signed by the Sole Responsible for the Procedure - RUP (see Article 22 of the Competition Notice) and sent to the Jury, which takes the decisions regarding eligibility. The Jury has the task of evaluating the project proposals. To this end, its work will take place in at least three reserved sessions; specific minutes signed by all the components and kept by the RUP shall be drawn up. The work of the Jury can be carried out remotely through telematic procedures that safeguard the confidentiality of communications.

The reports of the sessions, undersigned by all effective Jury members, defines the adopted method⁸ and the procedure of the works. The final report must contain the merit list with motivation for all competitors. Hence, the Jury establishes a merit list, identifying the winner - no ex-aequo is allowed, the winner proposals and the possible attribution of prize-money and the proposals that deserve special mention.

For each project — awarded or mentioned — the Jury draft a brief critical judgement. The Jury can also draft a general report on all presented and assessed proposals.

The President of the Jury immediately sends the above-mentioned reports to the RUP at the end of the Competition procedure and after the administrative procedure of taking note of the reports, the latter will be published on the website **www.sancristoforo.concorrimi.it**

14. PUBLIC HEARINGS

The work of the Commission of selection is preceded by a public session, during which the Commission of selection gives an account of the project proposals presented by reading or publishing the alphanumeric codes attributed by the telematic system to the various proposals, guaranteeing anonymity.

15. WORK OF THE JURY

In the reserved sessions the Jury defines the methodology of the works. The choice of project proposals will be made on the basis of the following evaluation criteria:

- 1. **Urban quality**, enhancement of urban relations and permeability in the design of open spaces, with particular attention to the relationship with the Naviglio (max. 18 points)
- **2. Functional quality**, multi-modal integration, cycle and pedestrian accessibility, with particular attention to the efficiency of the interchange (max. 18 points)
- **3. Environmental quality,** reduced impact on the soil, sustainability and circularity of the intervention, enhancement of ecological connections, resilience, with particular attention to biodiversity (max. 18 points)
- **4. Architectural quality**, recognizability and identity of the interventions from a compositional and architectural point of view, with particular attention to the "strong architectural identity" of the catwalk (max. 18 points)
- **5. Feasibility and durability**, quality of the project proposal with reference to the use of materials and construction technologies according to the construction time and existing infrastructure. Executive mode, durability, economic sustainability, maintenance, with particular reference to the catwalk (max. 18 points)
- 6. Quality of the Guidelines of Scopes 2A and 2B (max 10 points)

16. ANNOUNCEMENT OF THE WINNER

The Competition Authority, during the third public session, announces the winner of the Competition and reads out the **10** participants, by voicing their alpha-numeric codes, upon verification of administrative documents and incompatibility reasons.

Date and time of the public session will be published on the website of the Competition.

PART IV - FINAL OBLIGATIONS

17. Prizes and expense claims - Ownership of documents

The **winner** of the Competition shall receive a prize equal to € 40,000.00 (gross of VAT and any other charge foreseen by the law).

19. PRIVACY

The personal data supplied together with the application for participation in the competition will be processed by the Competition Authority (data controller) for the sole purpose of allowing the identification of the first 10 competitors classified in the competition. The treatment is based on the legal basis of the execution of precontractual measures adopted at the request of the interested parties and the fulfilment of legal obligations (in particular the Procurement Code, Legislative Decree no. 50/2016).

The data will be kept for 10 years after the conclusion of the announcement and any appeals.

They may be communicated to other subjects only for the purposes strictly connected to the competition, the management of information systems and the enhancement of the project proposals referred to in the following paragraph.
